AUTOPSY REPORT

SUMMARY:

A large collection of bones from all parts of the body, from at least 6 different individuals.

As established from anthropology examination most of the bones were from adults, but a number of vertebrae, an upper arm bone and a femur were from a person or persons under the age of 17. With a few of the bones it was possible to say that they were male, but with the majority it was not possible to say whether male or female.

Several of the bones were fractured including 5 of the 6 skulls present. In most cases it was not possible to say what caused these fractures or indeed to say whether they occurred before or after death.

One skull however, showed a clear gunshot injury, with a bullet entrance hole in the middle of the back of it and a probable exit at the front.

For this person, the cause of death was obviously a gunshot injury to the head, but for the others, from this examination, it was not possible to determine the cause.

CAUSE OF DEATH:

It is my determination that the cause of death in case number **GL02 018BP General Body Parts** was:

- 1. Gunshot injury to head**
- 2. Unascertained**

Numerous individual or groups of bones, many bagged separately. No soft tissue remaining, only muddy material adherent. Appears to be the remains of at least 6 individuals.

- Skulls:
 - of 6 present, only one intact, others show fracturing with large portions missing √
 - one shows gunshot injury, with circular entrance hole, 0.7 cm diameter, at back over occiput, with linear fractures radiating from it in various directions; fragmentation of vault and probable exit right frontal region √
- Thorax:
 - fractures of several ribs √
 - fractures of 3 of 4 scapulae present √
- Long bones:
 - fractures of a left humerus and left ulna √
 - fractures of 2 right and 3 left femurs √
 - fractures of one right and one left tibias, and a left fibula √
