SUMMARY:

The upper part of a body only – the head, chest and left upper arm – the remains being completely skeletonized, with no soft tissues attached whatever.

As established from anthropology examination, the person was male and aged between 31 and 65, but it was not possible to determine anything further.

There was disruption of two of the bones in the spine, which could have been part of a gunshot injury, but it was not possible to prove this or even to be sure that the damage occurred in life. Additional fractures of a few ribs on both sides of the chest were more likely to have been post mortem in nature from crushing or moving the body.

There were no other significant findings and so, from the examination, it is not possible to determine the cause of death in this person.
