SUMMARY:

A collection of assorted bones from all parts of the body from at least three individuals. There were no soft tissues surviving.

As established from anthropology examination, two of the individuals were adult and the other a younger person i.e. someone aged under 17. It was only possible with one bone to say that the person was male, with the others it was not possible to say whether male or female.

Several of the bones were fractured but pieces were missing and it was difficult to know what caused these or whether they occurred before or after death. None of them showed any particular features of gunshot damage.

The only other findings were a possible single shotgun pellet with the remains.

From this examination it is not possible to determine the cause of death in these persons.
