SUMMARY:

Much of the upper half of a body but minus the head, the right hand, some ribs and a few vertebrae from the spine. A lower jaw <u>was</u> present which may or may not have been from the same person and there was also a foot bone which almost certainly was from someone else. The remains were completely skeletonized, with no soft tissue remaining whatever.

As established from anthropology examination, the person was adult, aged over 22, but it was not possible to say whether male or female. If the lower jaw belonged to this person then he or she had obviously lost all of their teeth sometime in the past. Most likely the jaw did not belong to these remains.

Many of the bones were fractured – most of the ribs, several bones in the spine, both shoulder blades and the left upper arm – but most or all of this probably occurred after death, from crushing or simple erosion of the bones, given that the remains were near the surface.

The only possible genuine injury was a fracture of the left collar bone which may have been part of a gunshot wound, but it was not possible to confirm this one way or the other.

Apart from the fact that the person was wearing multiple layers of clothing there were no other findings. From this examination it is not possible to determine the cause of death.
