SUMMARY:

A largely complete body apart from the breastbone and a few ribs, a number of vertebrae from the spine and some of the small bones of the hands and feet. The remains were largely skeletonized but there was a layer of calcified material on the surface of many of the bones making them brittle and causing erosion. Presumably this was related to the soil conditions. There was some greasy material present as well.

As established from anthropology examination, the person was male, young – aged between 16 and 21 – and measured from 172 to 188 cm in height. There were no particular identifying features.

Many of the bones were fractured, particularly the ribs, shoulder blades and spine, but also the face and pelvis. Most, if not all, of these probably occurred after death however, particularly given the brittle and eroded appearance of the bones. It would certainly be impossible to exclude this. There was also a fracture of the right upper arm bone at the shoulder, which <u>may</u> have occurred in life, but it was difficult to confirm this one way or the other.

There were no other findings, and given the doubts over the injuries found, it is best to leave the cause of death in this person as unascertained.
