SUMMARY:

A more or less complete body missing only one of the left lower leg bones and the left foot, together with some of the small bones of both hands. There were a few extra face and neck bones from another person mixed in. The remains were completely skeletonized, with no soft tissue remaining whatever.

As established from anthropology examination, the person was male, aged between 17 and 29 and measured from 163 to 179 cms in height. There were no other identifying features.

He died probably from a gunshot injury to the chest, which had passed through two ribs and the spine.

There was also an unusual injury at the back of the head, with a rectangular defect in the skull and surrounding fractures. This did not appear to be a gunshot injury and more likely was due to some pointed object penetrating. Whether this occurred before or after death however, is difficult to say. The only other injury was an additional isolated rib fracture on the right side of the chest.

There were no other significant findings apart from evidence of burning on the clothing.

CAUSE OF DEATH:

It is my determination that the cause of death in case number GL05 011B was:

Gunshot wound of chest
