AUTOPSY REPORT

SUMMARY:

A largely complete body missing only the right hand and foot, occasional ribs and some bones from the spine. There was an additional fragment of skull from another person mixed in. The remains were completely skeletonized, with no soft tissue remaining whatever.

As established from anthropology examination the person was male, aged between 31 and 65, and measured from 168 to 184 cms in height. There were no particular identifying features.

There was evidence of a probable gunshot injury to the back of the chest, with fragmentation and loss of part of the spine and fractures of the ribs alongside, albeit with no metal fragments remaining in the body.

The only other injury was a fracture of one of the left lower leg bones below the knee but this may well have occurred after death.

There were no other significant findings apart from evidence of burning of the trousers he was wearing.

CAUSE OF DEATH:

It is my determination that the cause of death in case number **GL05 020B** was:
Gunshot injury to chest
