SUMMARY:

A complete body apart from the skull and the left hand, the remains being totally skeletonized.

As established from anthropology examination, the person was male and young – aged between 12 and 16. He was tall, measuring from 177 to 192 cms in height, but there were no other identifying features.

He died probably from gunshot wounds to the chest, pelvis and right lower leg, the first of these passing through the left shoulder blade and spine, and the other two passing through the right pelvic and shin bones respectively. A distorted bullet was found in the trunk.

There were also a number of fractured ribs on the left side of the chest, but whether these occurred before or after death is difficult to say.

The only other significant finding was evidence of burning of his upper clothing.

CAUSE OF DEATH:

It is my determination that the cause of death in case number GL05 036B was:

Gunshot wounds of trunk

Trunk:

- 1. Probable gunshot injury to chest producing:
 - small triangular defect in lower part of left scapula, 1.5 cm maximum of dimension, with bevelling posteriorly
 - loss of posterior spines of T1 to 4 vertebrae and fractures through bodies of T2, 3 and 4
- 2. Ribs left: fractures of 4 and 10 in axillary line
- 3. Probable gunshot injury to right side of pelvis, with apparent bullet hole below the iliac crest anteriorly on medial surface an oval hole, 1 x 0.8 cm and on lateral surface, an elongated triangular defect, 3 x 1.5 cms.
