SUMMARY:

A more or less complete body, missing only the right arm and hand, two bones from the neck and some of the small bones of the left hand and the feet. The remains were totally skeletonized, with only muddy material attached.

As established from anthropology examination, the person was male, aged between 31 and 65 and measured from 169 to 184 cms in height. There were no particular identifying features.

He would appear to have died from a gunshot injury to the chest, the bullet passing through the middle off the spine and damaging the ribs alongside. There were additional rib fractures elsewhere and fractures of other vertebrae, which may or may not have been related or been due to a separate injury.

He had also been shot in the face, with clear evidence of a bullet having passed through the lower jaw from left to right. The bullet itself was still lying alongside.

There were no other injuries or significant findings.

CAUSE OF DEATH:

It is my determination that the cause of death in case number GL05 044B was:

Gunshot wound of chest

Head and Neck:

 Gunshot injury to face passing through both sides of the mandible from left to right, producing a clear exit defect in the lower half of the right side in front of the angle, 1.5 cm diameter. Left ramus and part of body missing. Almost complete but distorted bullet found in the nasal cavity with a separate small jacket fragment alongside, presumably getting there post mortem.
