SUMMARY:

A substantial part of a body but missing most of the skull and neck, some of the bones of the chest and the left arm and hand. There was an additional rib from another person, someone under 17, mixed in. The remains were totally skeletonized with only muddy material adherent.

As established from anthropology examination, the person was male, aged between 31 and 65, and measured from 162 to 178 cms in height. There were no other identifying features.

There was evidence of a possible gunshot injury to the chest, fracturing two of the bones of the spine and an adjacent rib, but no bullet fragments remained and it was difficult to confirm this.

The skull was extensively fractured, with only a small piece of the upper part remaining. It was not possible to determine what caused this or whether it occurred before or after death. Similarly, with fractures of two ribs at the front of the right side of the chest.

There were no other significant findings, apart from evidence of burning of a single piece of cloth with the body. With the doubts over the various injuries which were found, it is best to leave the cause of death in this person as unascertained.
