SUMMARY:

A complete body missing only a single bone from the middle of the spine and some of the small bones of the hands and feet. The remains were totally skeletonized with only muddy material adherent.

As established from anthropology data, the person was male, aged between 24 and 55, and measured from 170 to 186 cms in height. There were no particular identifying features.

There was evidence of possible gunshot injuries to the chest, with one area of damage to the left collarbone and the breastbone, and another to the middle of the spine and the adjacent ribs. No bullet fragments remained however, and it is not possible to confirm therefore that they were gunshot injuries or even that the damage necessarily occurred before death.

There were additional rib fractures on both sides of the chest and a fracture of one of the bones of the left forearm, but most likely these did occur after death from crushing or moving of the body.

There were no other significant findings and given the doubts over the chest injuries, the cause of death, from this examination, is best left as unascertained.
