SUMMARY:

A largely complete body but missing the left hand and the right foot. The remains were skeletonized apart from some greasy material still attached.

As established from anthropology examination the person was male, young – aged between 15 and 21 – and measured from 164 to 180 cms in height. There were no particular identifying features apart from evidence of an old injury to the left side of his chest where there were three long since healed rib fractures.

He would appear to have died from a gunshot injury to the chest, the bullet having passed through one of the ribs on the back of the right side and damaged three of the vertebrae in the spine. There was an additional fractured rib on the left side of the chest but it was not possible to say if this was related or even whether it necessarily occurred before death.

The skull was extensively fractured but the appearances of the damage suggested that it probably occurred post mortem, from crushing or moving of the body.

There were no other significant findings.

CAUSE OF DEATH:

It is my determination that the cause of death in case number GL05 059B was:

Gunshot injury to chest
