AUTOPSY REPORT

SUMMARY:

A more or less complete body missing only the left hand, the left forearm and some small bones of the left foot. The remains were totally skeletonized, with only muddy material attached.

As established from anthropology examination, the person was male, aged between 17 and 33 years and measured from 175 to 189 cm in height. There were no particular identifying features.

An injury of the upper part of the right humerus was found which could be consistent with a gunshot. No bullet fragments were recovered. The other injuries were rib fractures, fragmentation of the skull and a fracture of the lower part of the left humerus, but it was difficult to know what caused these or whether they occurred before or after death.

With the absence of injury of the trunk bones and the doubts about skull injuries, the cause of death in this person must remain unascertained.
