# **AUTOPSY REPORT**

#### SUMMARY:

An almost complete diarticulated and skeletonized body with muddy tissues adherent, just missing the left hand.

As established from anthropology examination, the person was male, aged between 31 to 65 years old, and measured from 170 to 184 cm in height. There were no particular identifying features.

The investigation found fractures of the internal part of the left clavicle, of the head of the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> left ribs, of the transverse process of the vertebra C7, Th1 and Th2, and of the spine process of the same vertebrae. These fractures could be consistent with gunshot injuries. The cause of death could be the injury of the spine by gunshots.

He probably died from gunshot wounds to the trunk.

#### **CAUSE OF DEATH:**

It is my determination that the cause of death in case number **GL05 089B** was:

**Gunshot wounds of the trunk**
