AUTOPSY REPORT

SUMMARY:

A largely complete body apart from the head, some of the bones of the neck, and the left forearm, which were missing. A left hand was present but given the absence of the forearm it may well have been from another person. The remains were skeletonized apart from greasy material still attached in some areas.

As established from anthropology examination the person was a young man aged between 17 and 30 and measuring from 171 to 187 cms in height. There were no other identifying features.

There was evidence of a gunshot injury to the right thigh fragmenting the upper part of the femur, with the bullet probably entering through the outer surface of the leg. The only other injuries were fractures of one of the ribs at the back of the right side of the chest and of the left upper arm but they sleeved no specific features and it was not possible to say whether they occurred before or after death. There were additional rib fractures at the front of both sides of the chests but most likely these <u>did</u> occur post mortem from crushing of the body.

A gunshot injury to the thigh would be very disabling and could prove fatal if the person was left unattended, but this can not be proved in this case and so the cause of death, from this examination, is best left as unascertained, especially as parts of the body were missing, in particular, the head.

The only other finding was burning of some of his clothing, which presumably occurred after death.

It is my determination that the cause of death in case number GL05 102B was:
