SUMMARY:

An almost complete, skeletonized, disarticulated, remains of a body in clothing, missing the right hand with putrefied tissues in the pelvis.

As established from anthropology examination, the person was male, aged between 31 and 71, and measured from 164 to 178 cm in height. There were no other identifying features.

The investigations showed a fractured left scapula in its upper part with several fragments. The left humerus showed also a fracture with multiple fragments in the middle part (oval shape of the edges of the injury).

He died probably from a gunshot injury of the chest.

CAUSE OF DEATH:

It is my determination that the cause of death in case number **GL05 153B** was: **Gunshot injury to the chest**
